

## On-line Sweepstakes Rules

- 1. Introduction:** Penton Media Inc., d/b/a Delicious Living ("Sponsor") is offering the Online Sweepstakes ("Sweepstakes"). **NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

**Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the 50 United States or the District of Columbia.**

- 2. Eligibility:** Entrant must be a legal a resident of the fifty (50) United States and the District of Columbia, who is 18 or older as of June 1, 2014 and has not won a sweepstakes hosted by Sponsor in the last 18 months. - 4. How to Enter:** Visit <http://www.deliciousliving.com> and fill in required entry information. Limit one entry per person. More than one entry from any person (including entries from more than one email address or multiple entries from the same email address) will void all entries from that person. Entrants must have a valid email address. Sponsors may also ask optional questions. Completion of these questions is not required to enter the Sweepstakes. No automated entry devices and/or programs permitted. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic.
